

2022 Financial Plus School Supply Sweepstakes Rules

1. **ELIGIBILITY.** Financial Plus Credit Union “School Supply Sweepstakes” (the “Sweepstakes”) is open to entrants who, as of the entry date, are eighteen (18) and older. The Sweepstakes is void outside of the state of Iowa. Employees of Financial Plus Credit Union and their immediate family (defined as parents, spouses, children, siblings, grandparents and their respective spouses) or members of the same house (whether related or not) of each such employee are not eligible to enter.
2. **TIMING.** The Sweepstakes entry period begins at 8:00 a.m. Central Time (“CT”) on **Monday August 1, 2022** and ends at 5:00 p.m. Central Time (“CT”) on **Monday, August 15, 2022.**
3. **HOW TO ENTER AND COMPLIANCE WITH OFFICIAL RULES**
 - a. **How to Enter:** During the entry period, members can drop off school supplies and fill out the entry form.
 - b. **COMPLIANCE WITH OFFICIAL RULES:** Failure to submit all required information in the manner required in these Official Rules may result in disqualification. Entries will not be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt by Financial Plus Credit Union. Any submission that does not comply with any aspect of these Official Rules may be rejected by Financial Plus Credit Union and the entrant disqualified.
4. **AGREEMENT TO OFFICIAL RULES AND DECISIONS.** By participating in the Sweepstakes, each entrant fully and unconditionally agrees to be bound by and accepts these Official Rules and the decisions of the Financial Plus Credit Union (including, without limitation, decisions regarding eligibility of entries, the selection of entrants and the winner, and the awarding of the prize), which are final and binding in all respects.
5. **SELECTION OF WINNING ENTRY; ODDS; NOTIFICATION.** On or about **August 16, 2022** Financial Plus Credit Union, in its sole discretion, will select no more than one (1) winner from among all eligible entries received. Odds of being selected depend on the number of eligible entries received by Financial Plus Credit Union during the Sweepstakes. The winner selected must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. The winner will be notified by phone or email and will be required to execute a Liability waiver and Publicity Release. If the winner cannot be contacted within five (5) days of the first attempt to contact them then that winner may be disqualified and an alternate winner will be selected by Financial Plus Credit Union from all eligible non-winning entries received by the Financial Plus Credit Union during the Sweepstakes.
6. **PRIZE.** Subject to the terms and conditions of these Official Rules, one (1) prize will be awarded to no more than one (1) person. The prize will consist of one (1) **\$100 Visa Gift Card**. The retail value of the prize is \$100. Prize must be accepted as awarded and prize is awarded “AS IS” with no warranty, representation, or guarantee. No substitution prize is available. Winner is solely responsible for any and all costs, fees, taxes and expenses associated with prize award, receipt and use, including, without limitation, all federal, state and local taxes associated with the prize

and any travel required to collect the prize. If applicable, prize winner will be issued an IRS Form 1099 for the retail value of the prize. LIMIT: One (1) prize per person or address (physical or email) in this Sweepstakes.

7. **PUBLICITY.** Except where prohibited by law, participation in the Sweepstakes constitutes entrant's consent to Financial Plus Credit Union (and their respective designees', successors' and assigns') use of entrant's name, biography, likeness, voice, photographs, video, opinions, statements, hometown, state and country for promotional purposes in any manner or media (including, without limitation, online), worldwide, in perpetuity, and without further payment, consideration, notice, review or consent.
8. **GENERAL CONDITIONS.** Financial Plus Credit Union reserves the right, in their sole discretion, to terminate, modify or suspend the Sweepstakes if, in their opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Sweepstakes, or if viruses, bugs, unauthorized intervention, fraud, technical difficulties or failures or any other factor beyond Financial Plus Credit Unions reasonable control corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes. In such event, Financial Plus Credit Union reserves the right (but do not have the obligation) in their sole discretion to award a prize at random from among eligible, non-suspect entries received up to the time of suspected impairment. Financial Plus Credit Union reserves the right in their sole discretion to disqualify any individual they find to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately damage any or undermine the legitimate operation of this Sweepstakes is a violation of criminal and civil laws, and, should such an attempt be made, Financial Plus Credit Union reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. Failure to enforce any term of these Official Rules shall not constitute a waiver of that provision or any other provision of these Official Rules.
9. **Winner.** The winners name will be posted on the financial plus credit union website, www.financialpluscu.com, pending the acceptance of the prize.
